**REGISTRATION CERTIFICATES EXTENDED TO 31 JULY 2018** 

## Dear Stakeholders,

The Authority hereby wishes to revoke the industry circular, 'CUT-OFF DATE FOR THE RENEWAL OF OLD PSIRA REGISTRATION CERTIFICATES - 31 MARCH 2018', which was dated the 17<sup>th</sup> January 2018.

We have been monitoring your responses and have carefully took into consideration your comments and challenges experienced thus far since the above mentioned circular was issued. We want to ensure that we continue to provide excellent service without compromising your safety in the interim.

THE NEW CUT-OFF DATE FOR THE RENEWAL OF OLD PSIRA REGISTRATION CERTIFICATES HAS BEEN EXTENTED TO 31ST JULY 2018. This curt-off date is only applicable to Security Officers and Security Businesses who have not renewed their old PSiRA certificate and which still has old logo. Failure to do so before the extended cut-off date will render your registration certificate invalid for employment or trading for business.

Renewal forms can be downloaded from the PSiRA website, <a href="www.psira.co.za">www.psira.co.za</a>. Kindly note that no letter of good standing will be issued to businesses whose certificates have not been renewed. All Security Officers with the old certificates are expected to pay a renewal fee of **R40**. The renewal fee for PSiRA business certificate is **R290**. Key primary requirements for renewal include:

- Complete renewal form
- Old certificate or affidavit if lost
- ID copy
- Annual fees paid up to date
